



## **TERMS & CONDITIONS**

### **Raetihi Lodge Exclusive Use**

By booking your stay at Raetihi Lodge, you are agree to the following Terms and Conditions:

#### **Rates**

- All rates are quoted in New Zealand dollars and include 15% GST.
- We have a 3-night minimum stay throughout the year.
- Rates are subject to change and will be confirmed at the time of reservation.
- Public Holidays over Christmas/New Year incur a 15% surcharge per night.

#### **Booking Deposit Terms**

- A 20% non-refundable deposit is required to secure your reservation. We accept credit cards via our online payment system (Stripe) or direct deposit to our bank account with the following information:
  - Raetihi Holdings Ltd. – ANZ Bank # - 010598–0255584-00
  - Payments by credit card will incur a 2.5% surcharge
  - For direct deposits, we will issue an invoice for the 20% non-refundable deposit.
- The booking is transferrable, but not refundable.
- A further 50% of total amount is payable 30-days prior to your booking date and will be charged to your credit card on file or an invoice will be sent to you as a reminder for the direct deposit balance.
- The final 30% full balance and payment is payable on departure.

#### **Cancellation policy**

- Cancellations received with less than thirty (30) days' notice are subject to the non-refundable reservation deposit. Cancellations received with less than 14 days' notice are subject to a 60% forfeit of total booking period. This will be charged to the credit card number obtained with your booking confirmation and/or an invoice will be issued for the balance due.
- No shows will forfeit 100% total booking period.
- No refunds for early departures or dinner cancellations.
- It is recommended that travel insurance be taken out, in case of unforeseen circumstances.

## **Dining**
